- 8.6 Kalannie house \$90/week rent coming out of enterprise account at present need to cost out to projects at \$50/night no matter how many people book in house. Keys with Naomi Smith. Leave as found, i.e. clean on departure.

- 8.9 Advertise for NRMO position in Kalannie via free newsletters, Geraldton Guardian, Wongan-Balli Boomer. Ian transferred to projects. Employment committee will access NACC employment pool.
- 8.10 Oil Mallee project completed 1<sup>st</sup> year, \$11000 remaining for ongoing wages until IP2
- 8.11 NRMO funds Ian limited level. NACC decided to improve career path can now go to level 5.1 \$64,000
  - 8.12 Catchment Rehab funds
- 8.13 Accrued Annual Leave at present annual leave must be taken during project. People must take their annual leave, or lose it. \$10,000 accrued annual leave, but we don't have \$ to honour at present.

#### 9 General Business

- 9.1 Mike Clark IP1 Project presented by Jessica Hasleby
- NACC \$2000/km fencing incentive to assist farmers to fence off saltland retaining full use of land. 7 line with 2 barb and galv posts money could be better spent maybe with a more realistic fence, say 7 line only. Manage these areas differently to rest of farm
- 9.2 O.H & S steel cap boots, safety shirts, training for the drill rig, safety of backhoe pits need to obtain policy from NACC and then accept.
- 9.3 Monitoring of bore holes within zones. Possibility of landholders chosen to manage the bore holes in each zone? Can we pay landholders for this? e.g. Hepworth to do Bowgada zone. To use for scientifically there would be issues with reliability of information. Must be done accurately. Need to check every bore and then prioritise them maybe only 3 bores in each drainage line. NRMO's trained by Ian. Maybe one North and one South.

Encourage zones to apply for Envirofunds to monitor bores at a local level to attain trends for own catchment information.

Dene to follow up.

9.4 Cost Sharing arrangements for new drainage. How much should farmers contribute and in what way? At present funding supplies main arterial drainage line and then farmers put in equivalent length in spurs on property. Large financial burden up front for landowners. Looking at government system for drainage – farmers allow easement over land up to 100m wide in drainage line which would be their contribution. Easement could be reduced to (in good land) 50m in some cases – negotiate on a case by case basis. Then monitored and managed by YY with farmers paying a service fee - \$150/annum/km drain. Has been presented to Bowgada and Merkoonooka and received well. Value of drain \$15,000/km due to being designed to sustain 100 year rainfall events. Could put in one for \$6000/km. Maybe several options is appropriate, however difficult to operate two systems. Who will manage until Regional Body is in place? MOU – is the farmer prepared to let YY use land for x amount of time? Regional Council control with YY staff management. MOU's required for contracts to be accepted.

These funds will be paid direct to YY in the interim from State NRM, so that we can keep moving.

Max needs permission to write up contract with State NRM office and NACC which uses the easement method (in a benchmarking capacity) of farmer contribution. We need ratification ASAP due to permit approval process and contracting costs.

Max will complete and circulate before forwarding to State NRM and NACC offices.

Regional Council – MOU until regional council in place. Shires funding CEO of regional council. Has Stan put in submission to Regional Development Program? Dept of Water had committed funds as this is a pilot program. They could do \$25,000 added to \$30,000 from Shires – part time CEO. What do we want as far as easement – then John?? Will look at how to implement. Conditions – Time, personnel access, farmer continue cropping, rates. Can Max write up MOU which would appease funding bodies and circulate to farmers?
